Why talk about methods?

During the preparation of an evaluation or a performance audit, the most relevant questions must be defined. In order to subsequently answer these questions, the project team will then need to choose the appropriate methods, whether qualitative or quantitative, or both. Sometimes it is only by using several methods in combination ("triangulation"), that the auditor can obtain truly reliable results.

Traditionally the most widely used methods are face-to-face interviews, document analysis and sometimes data analysis. If applicable, other methods should also be considered, such as text mining, meta-evaluation, big data, focus groups, etc.

To understand the world, we must do justice to its complexity. The WGEPPP has decided to dedicate its Forum 2022 to the subject of methods: identifying and choosing the right methods and applying them judiciously. This is an essential subject for both public policies evaluations and performance audits. For this reason, WGEPPP has decided to open the Forum to performance auditors also. It is time to meet again in person, in order to exchange good practices and learn new techniques.

Target audience

This event is particularly suitable for

- regular members of the WGEPPP group, or
- experienced colleagues from all SAI, who are willing to present or discuss a performance audit or an evaluation, in which innovative or a combination of methods were applied

Event format

On the first day, renowned speakers will give keynote speeches. They will address the advantages and disadvantages of the main methods for evaluating public policies. In the afternoon, speakers from 12 countries will present methods used for performance audits or evaluations in the fields as social affairs, health or consumer policies. After the presentations of 20 minutes each, participants will have time for discussion.

The second day will focus on the practical application and selection of appropriate methods. In workshops, the participants will explore the following topics in greater depth: "Selecting suitable methods", "Methodical skills and knowledge managements" and "Finding topics and ways for successful international cooperation". The results of the workshops will be presented in plenary.

During the afternoon, both WGEPPP members and interested SAIs are welcome to the usual working group meeting with given agenda items. In the evening, participants will enjoy a nice evening in Bern.

On the third and final day, the WGEPPP offers an optional training in evaluation methods. This training has been co-financed by the Knowledge Sharing Comity (KSC) of the INTOSAI!

If your name is Bond, James Bond, you are definitely sure how your drink should be mixed, which vin millésime your Dom Pérignon should have, and that the hair color of the Bond-Girl is not important at all. The best is only good enough – and costs do not matter (by the way – I really wonder about the audit office at MI6 – the auditors at my university will get crazy if I present them such kind of bills of expense).

Well, we are not living in Hollywood and we have to choose our methods more faithfully than Mister Bond. By using our "weapons", we have to be more careful about collateral damages, we need to be more efficient in its use, and we have to think of cheaper "second best solutions" (Swiss wine is also really excellent, by the way). And this is what the course will be about: we will have a critical look at the empirical methods we usually use, discuss alternatives and new opportunities. This is not a course on how to do empirical research – in most cases you are commissioners of such kind of research, not researchers. It is a course for "gourmets": You need not to be a wine grower to get a wine expert – but you should now as much as possible of quality criteria for evaluating a glass of wine. This is what we are doing here.

We will tangle four different rubrics:

- Sampling criteria and sampling processes: when do we need representative samples, what do we
 have to look at if we are managing a sample procedure, when do we have to reject the sample as
 not appropriate, and what kind of consequences wrong sampling may have
- 2) Interviews and surveys: what are the differences between "good" or "bad" interviews, which kind of survey does produce which kind of errors, what are consequences of bad surveys
- 3) Observations and videos: how to reduce complexity of observation situations, are "cameras" better than "eyes" and what are the pros and cons? And what are the pitfalls we may get trapped in
- 4) Non-reactive measurements: this is about fingerprints, genetic tasting, automatic control, producing "Big Data" as well as "Big Brother". Can we always be sure that a quick clock is a perfect measure for time? Do we have to believe technical instruments, and can we be sure they will never fail? How to control and observe measurement and how to use them in a critical but adequate way.


